The problem of educators in Indonesia, including internal and external problems. The internal problem lies in the educator himself because he is often found by educators who do not meet the qualifications as teachers, so that in his teaching practice it becomes less interesting and not inspiring for his students. Second, external problems. The government as the decision maker must improve and evaluate the educational aspects that are lacking (Rohman, 2016) .
